Our Mission

The mission of STAR is to increase community safety by providing a Court team approach that provides accountability, treatment, recovery services and other resources to individuals on community supervision to assist them in changing their behaviors so that they live sober, law-abiding and productive lives.

Our program has three goals:

01

Address substance abuse, mental health and recidivism issues with high-risk offenders who are unable to succeed on general supervision.

02

For participants to live a sober, crime-free and productive lifestyle, which includes stable housing, employment and healthy coping skills

- during and after supervision.

03

To transform offenders' lives which will allow them to rebuild relationships with their family and friends resulting in them fully re-integrating into the community.



Our Story

Under the leadership of our former Chief Judge Audrey B. Collins, who is now an associate justice of the California Court of Appeals. We launched STAR - an acronym for Substance Abuse Treatment And Reentry in January 2010. STAR's mission is to try and change the way we interact with and treat criminal defendants. Our focus is on persons who are essentially career criminals who have spent more than half of their adult lives in and out of prison. Historically, what we have done to address this population is to arrest people for their drug-related offense. Prosecute and incarcerate them for X number of years. And then release them and then repeat. Nothing changes other than they've added a new felony conviction to their resume. Perhaps making them even less employable than before. So, why should we be surprised when they re-offend? What we don't do is effect any meaningful change.

While it was vitally important to gain the buy-in of the Chief Judge, the U.S. Attorney, the Federal Public Defender and the Chief of Probation; we still had to staff the program. The idea that a system could be designed in which the staff were individuals who already played integral and sometimes opposing roles in the criminal justice system was the brainchild of Kristie Rzonca, who together with her colleague Amy Young, first suggested that the Central District of California could follow the example of state court drug programs. This required the heads of each agency to provide staff for the program. One of the earliest members of the STAR team was Deputy Federal Public Defender Raul Ayala. Kristie, Amy and Raul were pioneers who embraced the idea that we can do a better job of addressing the root causes of criminality. They felt we could change behavior, which seemingly was unaffected by incarceration. They are special individuals. Two prosecutors come to mind who defied stereotyping and who took the effort to really get to know our participants, and with their patience and humanity were able to break down the barriers of trust inherent in the relationships between lifelong criminals and lifelong prosecutors. They are Steve Wolfe and Amanda Bettinelli. I learned so much from those two. That is not to say that learning how it should be done is the same as being able to replicate it. I could not.

What we are trying to do in STAR is simple: Disrupt and hopefully end the recurring vicious cycle of drug-related incarceration.

One of the first things that we try to do is get a grip on the addiction. Unless they are clean and sober, our participants have no chance of succeeding. Most of the drug court programs in this country—including STAR—use evidence-based methodology consisting of immersion in a 12-step program, and weekly meetings with the court team comprised of prosecutors, defense attorneys, probation officers, drug counselors and the supervising bench officer. This is coupled with life skills training, Moral Reconation Therapy, individual and group therapy, cognitive behavior therapy and mental health counseling – all of which are designed to correct criminal thinking and provide tools to remain sober.

Our participants come to understand we are there to support their efforts to change their lives and have no interest in seeing them fail – which we view as our failure as well.

They understand that we recognize that relapse is a part of recovery. And while we are not pleased about relapse, we understand it and will take steps to intensify their treatment. What we will not condone, however, is the commission of a new crime. That will likely result in termination from the program and return to prison.

Our objective is to permanently remove our participants from the criminal justice system and return them to their families-- and the community, sober, crime free with steady employment.

We've actually turned many lives around by focusing on the causes of their criminality, encouraging participants to rid themselves of old associates and replace those old associates with new ones. They learn to embrace their sobriety and their freedom. We all look forward to the day when this more enlightened approach becomes the norm. Of course, the success of such a program is heavily dependent on dedicated professionals willing to try something different. Professionals who won't accept as a reason for resisting change "well that's the way we've always done it." The STAR team recognizes that the way we've always done it has produced woefully sorry results. Our dedicated team members have been successful in resurrecting hopeless futures, reuniting families, stopping the revolving door and saving lives. They are to be congratulated.

REPORT FROM STAR-LOS ANGELES 2020-2024



STAR-Los Angeles team is proud to be in its 15th year of serving the Central District of California, Western Division. STAR-Los Angeles program continues under the direction of founding judicial officer Hon. Otis D. Wright II and Hon.

Rozella A. Oliver. During the past four years, we have had much to celebrate. We held five formal graduation ceremonies, in which we joyously celebrated the hard work and accomplishments of the 35 participants that successfully completed the program. Moreover, in our ongoing effort to provide our program participants with support and resources needed to create positive and life-long changes in their lives, we added a number of new and innovative components to our core program including:

- Addition of social workers to each STAR team
- Engaged in team trainings focused on trauma informed care and resilience
- Added a Peer Recovery Coach to assist the participants and work with the team

TRAUMA-INFORMED CARE TRAINING March 13, 2024

In our ongoing effort to utilize restorative justice and evidence-based practices to assist our participants with their goal of making positive changes in their lives, on March 13, 2024, the STAR team in conjunction with the Federal Judicial Center held a training on trauma-informed care. The training was held at the 9th Circuit Courthouse and all STAR and CASA team members were invited to participate. The training was facilitated by Christina Ruffino of the Federal Judicial Center and led by USC Professors of Social Work, Dr. Rick Ornelas, DBH, MSW and Dr. Rosemary Alamo, DBH, MSW, LCSW, PPSC.



STAR-LA PEER SUPPORT GROUP 2020-Present

STAR-LA continues to hold its monthly peer-support group meeting. The meetings are facilitated by Recovery Coach Gary Meeks and retired U.S. Probation Officer and FPD investigator Steve Wells. The meetings are an opportunity for participants, alumni and observers to share connect and support each other.



NEW STAR SUPPORT COMPONENT

Social Work Support, 2019-Present

Beginning in 2019, social work staff from the Federal Public Defender's Office have been assigned to work with participants in all three STAR courts. The social workers provide a holistic advocacy approach by connecting the participants to services that address barriers that may hinder their path to successfully completing the program. The social workers focus on the participants underlying issues and connects them to the appropriate community resource such as addiction recovery programs, mental health treatment, educational and job training programs. The team's social worker encourages the participants to be truthful with the with the team when they relapse. Though the social worker cannot give legal advice, they do discuss and explore with the participants the long-term benefits of sobriety and a healthy lifestyle.

STAR YOUNG LEADERS WORKSHOP May 2024

Kristie Rzonca is a founding member of STAR and the glue that holds it all together. She joined the U.S. Probation Office 24 years ago. As a Drug Specialist Probation Officer for her first nine years in Probation, Kristie

participated in many revocation hearings spurred on by addiction and thought there had to be a better way of handling cases involving defendants that were living with an entrenched drug addiction and/or mental health issues. Kristie and a colleague at Probation first met with Judge Wright in 2008. Out of that meeting, came the idea of creating a drug reentry program in the federal system in the CDCA. Since that meeting more than fifteen years ago -- Kristie has been directly involved in helping STAR participants change their lives. Kristie knows that collaborative court programs work because they meet individuals where they are. She is a proponent of connecting STAR participants to wraparound substance use disorder and mental health services to help them build a sustainable support system that people take with them into the world after graduating from the program and finishing their terms of supervised release. As Kristie says, "You have to chase your sobriety the way you used to chase that dope!"

Kristie's other full-time job is being a hockey mom to a high schooler and a middle schooler. She also loves to garden and cook. Kristie is set to retire at the end of 2025. Giving back in my role as the STAR Recovery Coach gives me the opportunity to help the current participants in the program. I successfully completed STAR in 2020. Even after I graduated, I stayed connected to STAR. I continued to participate in the monthly community service at the LA Food Bank. and attend other STAR events. When Judge Wright and Kristie asked me to become a mentor to new or struggling participants I jumped at the opportunity to be of service to my STAR peers and the team. This new role was important to me because I struggled with accountability in the past. Being placed in this position of trust with the team helped me stay grateful, connected and focused on my own recovery.

Having STAR participants contact me with questions and seek me out when they run into issues while programming in STAR is also a reminder of how far I've come in my recovery. I give the participants the truth from my experience with the STAR team and my own struggles with recovery. I urge them to do an honest program without taking shortcuts. I facilitate the monthly peer group meetings; I lead a weekly recovery group, and I meet with all incoming STAR-LA participants. I let the new participants know that I am there to help guide them through the tough early stages of the program. I've heard so many times in AA meetings 'that in order to keep it, you have to give it away'. To me that means being of service and giving back. By being put in this position of trust by the team helps me be a part of something greater than myself.

I can speak from my own experience that staying connected to STAR has made the promise of the Big Book come alive in my life. It has become a fact in my life that one alcoholic or addict helping another keeps them both clean and sober. I'm betting my life that it's true.

STAR-SANTA ANA FIRST GRADUATION CEREMONY JUNE 5, 2024

On June 5, 2024, the STAR-Santa Ana program held its first formal graduation ceremony. The ceremony was led by U.S. Magistrate Judge and STAR team member Hon. Maria A. Audero. We were honored to have STAR founder Hon. Otis D. Wright II, give opening remarks. The four participants that graduated that day: Sheila Lee Cundall, Hung T. Nguyen, Alex Payan and Madeline Scardina were encouraged to share their personal journeys of resilience and triumph over their substance use and mental health issues that had plagued each of them for much of their lives. They did not disappoint. As graduate Sheila Lee Cundall shared in her speech:

"Before STAR, I was dealing with a lot of chaos. Everything in my life was negative. I was in and out of prison. There were suicide attempts. My best friend of 25 years died. It was really rough. So, for me to stand here today is a miracle. I have 322 days clean. I've learned to take responsibility for my actions. I thought I could skate through [STAR] without making any real changes. As an addict/alcoholic, I didn't want to give up my ways of going through life "self-medicating" for five decades. I tried to evade drug detection, which is impossible and difficult to sustain. It was a relief when Judge Carter sent me to rehab, I was looking at real prison time. I finally surrendered. That was 322 days ago. It's an honor to be a pioneer as one of the first graduates of this program."

ALL-STARS | GRADUATE PROFILES

AMANDA BOKOBZHA

2024 STAR-LA Graduate



My journey with STAR began in April of 2022. Just two months prior, I had returned home from prison, and not long after, I overdosed on fentanyl. At the time, my probation officer suggested I give STAR a try, but I was torn—one foot in, one foot out. During my interview with Judge Wright, he asked me point-blank, "You want to die, don't you?" And the truth was, I did. I was a coward, running from life, hoping I could get high without facing the consequences.

For the first year, I didn't take STAR seriously enough. When I made bad choices, I tried to hide them and if I couldn't, I'd play the victim and attempt to manipulate people into believing my lies. It's a pattern I had engaged in my whole life, one that pushed people away and left me with nothing. Even rehab programs, courts, sponsors—they all grew tired of my excuses and eventually gave up on me.

But STAR didn't. The STAR team saw something in me that I couldn't see in myself. They believed in me when I didn't know how to believe in myself. With their patience, guidance, and support, I've done something I never thought possible: I've been sober for 18 months. Not just sober, but truly in recovery.

For the first time in 34 years, I can say I'm proud of who I am today. I have integrity. I am reliable. I am capable. I didn't do this alone—I know that. Addiction is not just about the substance; it's about the behaviors, the patterns that shape who we are. And those behaviors have consequences. But with STAR's constant guidance and accountability, I've made it this far.



SAULINA EADY

Life is all about the choices you make, and my story is no different. In hindsight, I've realized that my childhood environment had a profound effect on how I learned to perceive the world. Growing up, I wanted to make good choices but there was something about my environment and my lack of life tools that often led me to engage in risky behavior instead. My life took a not-so-positive path. I eventually landed in jail and was on my way to prison. During my incarceration, I had a lot of time to detox, clear my mind, and begin to process how such a promising child could end up like I did as an adult. I could no longer use drugs and the fast life to numb my shame, guilt, and anger. I had to finally face myself and peel back the layers of who I had become. I realized that I had hit rock bottom and I desperately wanted to change that narrative about myself. I slowly began to piece together a daily program for myself. I took advantage of all of the resources I had access to, willing myself to try everything even if I didn't feel like it. Through that process, I learned to take advice and embrace opportunities. I incorporated what made sense for me into my plan to get my life back on track.

When I got to the halfway house, I threw away my "keep silent" attitude and began asking for help. When one resource didn't work, I asked for a referral to another and then another. I kept doing this until I was introduced to STAR. This is where things got interesting.

STAR brought everything I was beginning to learn about myself into focus. It gave me the final nudge I needed to make the big and little improvements in my life. My children's custody situation was the biggest problem I wanted to fix. STAR supported me. I never thought I could have a job with benefits and an opportunity to move up the ladder. STAR believed in me and I am now a proud LA County employee. The STAR team walked me through my journeys, helping me align myself with values I can be proud of.

STAR also inspired me to help others. I don't focus my energy on self-destruction anymore. Instead, I make myself available to people who have walked in similar shoes as me. I tell them about resources I know of. I encourage them to adapt and learn like I did. I tell them to never take "no" as a final answer. Even if we don't get the response we want, we can never let that two-letter word take us away from our bottom line: SUCCESS!

SARAH ("PINKY") BALDWIN

To be honest, I am very nervous talking about myself. However, when my therapist asked me to write this, I felt obligated to share how the STAR Program helped me change my life.

Before STAR, I was in the CASA program. I was doing well for a while. However, as I got close to graduation, I began feeling scared and overwhelmed. It felt like I was faking it, and I would let everyone down. So, I did what I always did. I ran. I relapsed and went back to living on the street. I stayed in abandoned buildings hiding from the world. I was in big trouble and I didn't know what to do. However, something amazing happened during that time. I began getting phone calls from the CASA Team. Instead of being angry, they called to see if I was okay. That shocked me. When I got in the STAR Program, that experience helped me realize the STAR Team cared about me as a person.

My experience in STAR was amazing. My life has changed entirely. I have gone from living on the streets to living in a beautiful sober-living home. I used to feel a sense of alienation. Now, I am surrounded by supportive, likeminded women. I have been able to make amends to family members. We are rebuilding our relationships. This is so important because I thought I would never be able speak to them again. In recovery, I have done other things I am proud of. I have been volunteering at a homeless outreach program each week because I have a special place in my heart for the homeless. I have worked hard to obtain things that other people take for granted like owning my own vehicle. I have a bank account and I learned how to pay bills. These simple tasks used to frighten me!

The thing I am most proud about is pursuing my education. It has always been my dream to get a college degree. Since being clean, I work toward that dream every day. I remember doing my check-in with STAR and saying, "I am now a college student!" It sounded so unreal. Yet, STAR helped me make it real. It is hard work, but I will not give up working toward my dream. I will get a degree in social work and continue helping the homeless. I want to thank the entire STAR Team for helping me believe I could achieve this dream. On November 22, 2023, I celebrated two years of clean time.



ALEX PAYAN

When I first started the STAR program, my life was a total disaster. I felt hopeless and defeated. My relationships were broken. I was unemployed. I had a severe addiction and just got released from jail.

As I entered orientation for STAR, I didn't have a clue of what to expect or what was expected of me. But just being around these individuals gave me a sense of hope. Seeing and hearing life challenging struggles and testimonies from my STAR peers gave me such motivation and kept me moving forward. The process wasn't easy but it wasn't impossible either. Not only my group members but the team were such a help in my recovery. I got in trouble for a few setbacks but then I also got positive feedback. I really needed that challenge. Instead of giving up, I stayed. I had a lot of irrational thoughts during that that time.

Thank God I stuck around for the long ride. As weeks, months kept flying by, I worked on changing my relationships and making them healthier. I worked on my mental health with Lance (the SA team therapist). I set healthy goals for myself. I stopped doing drugs because doing drugs did not fit into my healthy lifestyle. I started attending 3-4 NA meetings a week, which at first I didn't enjoy doing but adapted very quickly. Of course, in general the process like I said wasn't easy but for me it such a humbling experience and for the newcomers and future STAR newbies if made it to the finish line a guy, who was in and out of prison being in the streets I know you can make it as well. Just trust in yourself and the process.

Last but not least, I would like to thank the whole STAR program Thank you all for your help in my times of need and for believing in me.



STEVE MARTIN

I joined the STAR program in July 2022. I was very hesitant about joining the program. But in the end, being in the program turned out to be a blessing for me. Even though I had a few bumps along the way during my time in the program, the Team never gave up on me. They always lifted me and were very supportive. At different points while I was in STAR, I was spiraling out of control. I struggled a lot during that time in my life. I realized that the team really cared about me. And their caring, made me want to do better. I wanted to be better for my family, for myself and make the team proud of me.

I have come a long way since completing STAR two years ago. I am proud to say that I have been officially off "paper" (court ordered supervision) for the first time in my life in almost 20+ years. I have abstained from drinking alcohol for more than two years. My family is proud of me. And I am proud of myself. I continue to be self-employed, and I am in the process of launching my nonprofit "Getting It Done Without a Gun." The nonprofit is a youth intervention program that I hope to run with several friends. We know what's it like to be out there in the streets. And our mission is to talk to the kids wherever they are -- be in in youth authority, at school, in the churches. I hope to recruit women mentors as well to talk to the young women in our communities. We know and understand that early interventions with young people work the best.

I think being in the STAR program really helped me understand what it takes to be sober, responsible and live a different kind of life. I'm still the same person, but I just think differently now. There were times when I thought I wouldn't make it to the finish line. I'm not going to lie. STAR can be overwhelming at times -- but some people -- like me need that structure. It helped me to be more disciplined and become a better listener. I learned to be humble and not react first.

Overall, STAR is a great program, and I would recommend it to anybody that is serious about changing their lives and getting themselves together. It truly worked for me.



RAYMOND BENAVIDES

I learned that I had to surrender to be there for my daughter.

I had to surrender to STAR to get help with my addiction.

It's hard to believe I'm the man that spent eight and a half years in prison. I'm a different man now. I'm a devoted father to my young daughter. I'm a dedicated employee; I work for Amazon. And I'm a proud STAR graduate.

My life has changed tremendously in the past three years since I was in STAR. My early life didn't start out great. I went to Artesia high school and got kicked out in the first month. I went to continuation school. I completed 10th grade; then I left. Mom and Dad split up a year before. My dad died at 38 from drug addiction. He didn't know how to be a dad. My grandmother was an alcoholic. After I got out of prison, I violated my supervision. I was referred to STAR by Judge Fischer and my DFPD Kim Savo. I did 15 days in custody. While I was in custody, I received a photo of my newborn daughter from my girlfriend. Seeing the picture of my little girl changed me. I got out of custody and went into treatment at Phoenix House. I learned there that drug addiction is a disease. And, that it can be treated. I completed the program because I was open and willing to change. I met with the therapist once a week. We talked about my childhood stuff. I learned a lot about myself. The therapist and I dug deeper and all that stuff from my childhood came up. We talked about everything.

On my journey to recovery, I had some big wake up calls that made we want to change. The first was when we learned that my mom had a brain tumor. She wanted me to do better. She needed me to do better. The second wakeup call was when we learned that my daughter might have a tumor. I knew that I had to grow up. I had to be someone that my family could count on. It drove me to be more productive and to focus on my sobriety. Also, being a father to my daughter motivated to want to do better. I missed a lot with my other kids, I was not as close to them because I was not there. I was locked up. With her, I get to be there with her and be present as a father.

I still stay connected to STAR even now that I've graduated because it keeps me grounded and accountable. And that works for me. I still attend NA meetings; STAR court meetings and help at the Food Bank. I'm now the one telling newcomers to trust the process and to trust STAR.
